This project includes a 2 year bridge painting warranty, a 5 year epoxy overlay warranty, and a 2 year warranty on concrete surface coating. Alternate 1 (section 2) is an HMA alternative and contains a 5 year materials and workmanship pavement warranty. Alternate 2 (section 3) is a concrete alternate and contains a 5 year materials and workmanship pavement warranty. Only shortlisted contractors are eligible to bid on this project.
