This typically leads to a stiffer layer which we are seeing when we test with the falling-weight deflectometer. Resilient modulus values backcalculated from the FWD are in the range of 30,000 psi for dense graded bases, while for crush and shaped HMA layer are usually higher - as high as 100,000 psi. Thanks for the question.
