E ach year, Michigan public transit systems provide millions of rides to Michigan citizens; almost 100 million rides in 1986 alone. For many people a bus is the key to an independent lifestyle while, for others, a public bus is vital transportation to work or to school. Whatever the need, people rely on public buses for safe, dependable transportation; and Michigan's public transit systems proudly meet the challenge!

Michigan Public Transit: Profiles in service is a celebration of Michigan public transit's commitment to excellence. Each page profiles one of our 73 urban and nonurban transit systems, highlighting its individual services and system characteristics. We urge you to read these profiles and become more familiar with Michigan public transit as well as your own community bus system.

The first section of this book features topics important to public transit. Issues such as

senior and handicapper accessibility, specialized services, transit funding and much more are included in this section.

Michigan Public Transit: Profiles in Service also features Michigan Public Transit's Heart-O'-Gold Award Recipients. These public transit people have been honored by the Michigan Department of Transportation (MDOT), as well as their local communities, for their outstanding humanitarian deeds. These remarkable people represent the very best in public service, and we are proud to highlight their extraordinary community service contributions.

Michigan has long recognized the need for public transit services and supports the development of both urban and nonurban systems across our state. MDOT's Bureau of Urban and Public Transportation administers programs to increase the effectiveness of Michigan public transit and to meet each system's individual needs; whether it be urban, nonurban or specialized service.

Michigan is proud of the tradition of excellence established by our public transit systems...we hope you'll enjoy learning more about them!

# MICHIGAN PUBLIC TRANSIT FUNDING: AN OVERVIEW


Michigan's public transit systems receive funding from three important sources: federal, state and local. The following is a brief description of how each of these three sources contribute to funding local bus services in our state.

In Michigan, transportation funding is provided from state funds allocated from fuel, vehicle registration, and other minor taxes.

Currently, Michigan has a 15 cents per gallon gasoline fuel tax, a 9 cents per gallon diesel fuel tax, and a vehicle registration fee. The 15 cents per gallon gasoline tax is distributed as follows: 4.9 cents per gallon for state highways, 4.9 cents per gallon for county roads, 2.7 cents per gallon for city streets, 1.4 cents per gallon for public transportation, and 1.1 cents per gallon for costs related to collection.

Revenues from these sources make up the Michigan Transportation Fund (MTF). In 1986, approximately 66 percent of the MTF revenue was derived from fuel taxes, 31 percent from vehicle registration and three percent from other minor taxes. This fund is divided approximately 90 percent to highways, roads and streets, and 10 percent to public transportation, through the Comprehensive Transportation Fund (CTF). The CTF also receives revenues from the sales tax on automotive-related products and other miscellaneous revenue.

In Fiscal Year 1985-86, the CTF collected \$134.5 million. After deducting debt service on bonds and administrative costs, approximately \$103 million was distributed as follows:



#### **OPERATING ASSISTANCE - URBAN**

Currently, there are 14 urban public transit systems serving Michigan communities. These systems operate in Ann Arbor, Battle Creek, Bay County, Benton Harbor, Detroit, Flint, Grand Rapids, Jackson, Kalamazoo, Lansing, Muskegon, Niles, Port Huron and Saginaw. These systems receive funding from three main sources, and in FY 1986, the sources were:

The Local Revenue/Farebox category includes funds raised through bus advertisements, local millage revenue and local general fund allocations.

Urban transit systems receive operating funds from both federal and state programs. Act 51, of 1951, as amended in 1982, provides state funds for operating assistance, and Section 9 of the federal Urban Mass Transportation Act of 1964, as amended, provides for federal operating assistance.


Under the *state program*, urban systems can receive up to 50 percent of eligible operating costs not paid by a federal program.

Federal operating assistance is limited to a percentage of the urban system's 1982 operating assistance amount. (This percentage varies from 80-95 percent, based on factors such as size, etc.)

# OPERATING ASSISTANCE - NONURBAN

Michigan is a national leader in providing public transit service to its rural and nonurban area residents. In FY 1986, Michigan had 57 nonurban public transit systems operating across the state. These systems receive funding from the same sources as the urban systems, but in different proportions.

Like the urban systems, nonurban systems receive operating funds from both federal and state programs. The federal Section 18 program provides up to 50 percent of a nonurban system's net operating costs (total operating costs less farebox). The state then provides up to 60 percent of the eligible operating costs not paid by a federal program.

We have looked at the state and federal programs funding public transit, now let's examine revenue sources at the local level.

Many different mechanisms exist for local funding of public transit services. Some transit systems receive annual funds by appropriation from the city or county budget. Others rely on a voter approved property tax millage. Millages and budget appropriations provide a relatively stable funding base, but it is also important to transit systems to build revenues from other sources, such as passenger fares, advertising, and human service agency contracts.

Farebox revenues are a vital source of local transit revenues. Fares are the one direct way users (riders) contribute to the support of the system. Transit managers, working with local advisory groups, set fare rates based on ridership and revenue projections as well as other cost factors.

Many systems sell bus advertising as an additional source of local revenue. In addition to earning money for the system, this practice helps build a stronger relationship with local business people. As businesses and service organizations get involved in bus advertising, the community becomes more aware of public transit's contribution to the economic development of their area.

Another valuable source of revenue to many public transit systems is from contracted transit services provided to local human service agencies. These service arrangements are encouraged by state and federal funding agencies as an excellent tool for coordinating services and for the most efficient use of public funds. Agencies, such as the Michigan Department of Social Services or Department of Mental Health, or area offices on aging or school districts, etc., may contract with a local transit system to coordinate and provide transit services. Under these contracted service arrangements, everybody wins!

Yearly budget appropriations from city, county or township governments, are another source of local revenue for some transit systems.

Voter approved millages are another significant source of local revenue for many public transit systems. In Michigan, 38 public transit systems now receive revenue from local transportation millages....and more are being added to this distinguished list every year! Millages provide a stable source of local revenue for the transit system and represent a measure of community support for the system.....both of which are extremely important!

#### CAPITAL GRANTS - URBAN

Capital assistance (buses and related equipment) for urban systems is funded by both federal and state programs. Section 9 of the federal Urban Mass Transportation Act provides 80 percent of eligible capital costs for urban systems with the state providing a 20 percent match. New facilities for urban systems are generally funded through federal-state matching programs. Section 3 discretionary funding is also available for large capital projects.

#### CAPITAL GRANTS - NONURBAN

The state provides 100 percent of the funding for capital expenditures (vehicles and related equipment) for nonurban systems. Federal programs do exist; however, for some facility funding (on a federal/state matching basis) and limited vehicle purchases. Michigan has used Section 3, discretionary funding to provide for 75 percent of eligible costs of facilities with the state providing the 25 percent match. Section 9 funds transferred from urban systems have also been used to fund nonurban facilities on an 80/20 match basis. If federal funds are not available, nonurban systems have the option of matching state dollars with local dollars to fund facilities.

#### **NEW SERVICES PROGRAM**

The New Services Program provides assistance to eligible governmental units to implement new public transit services. For new systems, capital and net operating expenses are entirely funded by the state for the first two years of operation. In the third year, operating costs are shared with the local area-75 percent state and 25 percent local. In the fourth year, systems are funded the same as other systems. Consolidation and coordination of transportation services at the local level are significant parts of the new services system design.

# SPECIALIZED SERVICES

#### Meeting Special Transportation Needs

illions of our citizens, especially seniors and handicappers, have special transportation needs . . . and access to public transportation is an important factor to their well-being. The State of Michigan recognizes this and created the "Specialized Services" program to meet these special needs.

The Specialized Services program is a cooperative effort between the state and federal government. Private, nonprofit organizations can receive capital assistance (buses, vans, radios) and operating assistance (fuel and maintenance) to meet the special transportation needs of seniors and handicappers in their area.

The program is administered to private, non-profit agencies who make application to the state for assistance. To receive funding, an agency must document its client's special transportation needs and show that the majority of its service will be provided outside the service area of any existing state-funded transportation provider. This requirement prevents duplication of transportation services in an area and helps to maximize financial resources. In addition, the agency must try to obtain local funding and coordinate services with other local transportation systems.

Participating agencies can receive vehicles and equipment funded, 80 percent by the federal government (through Section 16(b)(2) of the Urban Mass Transportation Act). Michigan provides the matching 20 percent as well as

operating assistance based on a specified "rate per mile". Public Act 51 of 1951 provides up to \$850,000 per year to be set aside to serve our state's seniors and handicappers through this program.


Currently, Michigan has 53 nonprofit organizations participating in this program. During 1986 Specialized Services agencies provided 594,220 passenger trips in the following counties:

# SENIORS, HANDICAPPERS AND MICHIGAN PUBLIC TRANSIT

Michigan buses provide over 22 million rides to seniors and handicappers each year! That constitutes nearly 25 percent of our total bus ridership!



Michigan public transit recognizes the importance of public transportation to the health and well-being of seniors and handicappers. Over 53 percent of all Michigan buses are now lift-equipped to accommodate people with wheelchairs or walking disabilities.

Statistics, however, do not tell the real story of public transit or the impact it makes on the lives of people. Traci Allen, for example, is a dynamic and charming young woman from St. Johns, Michigan. Traci also happens to be a handicapper who uses a motorized wheelchair. For many years, Traci has relied on the lift-equipped public bus in St. Johns for transportation. In high school, Traci joined the Big Sisters organization. She and her "lit-

tle sister" would go shopping, to the movies and to school -- thanks to public transit.

All over our state, senior citizens, like Nellie McDonald depend on public transit to get to the local senior clinics and centers. Nellie McDonald also relies on public transit to take her to the local nursing home where, twice a week, she visits her husband Ed. Enriching the lives of Nellie and Ed McDonald, Traci Allen and many, many others is the real story of public transit

To assist seniors and handicappers, Michigan created the Specialized Services program. This program is administered at the state level to provide state operating assistance and to maximize federal funding of transportation for senior and handicapper citizens. Participation in such special programs, use of lift-equipped buses, and friendly helpful drivers, reflect Michigan public transit's commitment to our senior and handicapper citizens.

Public transit systems are dedicated to improving the convenience and increasing the accessibility of their services. All public transit systems offer discounted fares for their senior and handicapper riders during off-peak hours, and many systems offer additional discounts whenever possible. These and other such services play a key role in improving the quality of life for many seniors and handicappers in Michigan. By meeting basic transportation needs, public transit makes an active lifestyle a reality for a growing number of our senior and handicapper citizens.

As America's "baby boomers" approach "senior status", the number of senior citizens in our society will increase dramatically. Added to this, more and more seniors are choosing to live at home. Soon, society will be compelled to address the ever-increasing transportation needs of these senior citizens! Public transit is the key.

# MICHIGAN PUBLIC TRANSIT - QUESTIONS AND ANSWERS

- 1. Q. HOW MANY PEOPLE RIDE THE BUS?
- A. Michigan public transit provided nearly 100 million rides in 1986 alone!
- 2. Q. DOES PUBLIC TRANSIT ACCOM-MODATE SENIORS AND HANDICAPPERS?
- A. Yes! Nearly 25 percent of all transit riders in Michigan are seniors and handicappers! Discount fares are offered both seniors and handicappers and over half of the buses in Michigan are equipped with special lifting devices for handicapper accessibility. In addition, the Specialized Services program administered by the state is geared especially to the needs of seniors and handicappers.
- 3. Q. WHO BENEFITS FROM PUBLIC TRANSIT?
- A. Everyone! Students who depend on public transit to get to school, benefit. Seniors who rely on public transit for mobility, benefit. Handicappers who need special lift-equipped vehicles, benefit. Workers, shoppers and commuters benefit too. ALL citizens benefit from reduced traffic congestion in our cities, from profits earned when shoppers have transportation to businesses, and from the jobs public

transit, as employers, creates. Public transit improves a community's "quality of life!"

- 4. Q. WHERE ARE PUBLIC TRANSIT SER-VICES AVAILABLE IN MICHIGAN?
- A. Michigan public transit services are available in 80 of Michigan's 83 counties.
- 5. Q. HOW IS PUBLIC TRANSIT FUNDED?
- A. From several sources. Currently, public transit systems receive funds from federal, state and local sources:
  - 19 percent federal
  - 35 percent state
  - 46 percent local
- 6. Q. DO ANY PUBLIC TRANSIT SYSTEMS BENEFIT FROM LOCAL MILLAGES?
- A. Yes! Thirty-eight public transit systems in Michigan now receive funds from dedicated local millages.
- 7. Q. ARE THERE ECONOMIC AD-VANTAGES TO PUBLIC TRANSIT?
- A. Yes! Public transit is the most economical method of moving large numbers of people in our densely populated urban areas. When people ride the bus, fewer automobiles crowd our busy roadways. Since many riders are shoppers on their way to stores and shopping malls, shopkeepers profit from increased business. And, public transit systems provide over 4,600 jobs in Michigan every year!

 Access to public transit means independence to thousands of Michigan citizens: young, elderly, handicappers, students, and workers.







# MICHIGAN DEPARTMENT OF TRANSPORTATION

#### "Heart O' Gold" Awards

The Michigan Department of Transportation's Bureau of Urban and Public Transportatin (UPTRAN) established the Heart O'Gold award in April, 1987. This award recognizes "extraordinary public service" by public transit personnel.

The department recognized that drivers, dispatchers and other public transit people on the front line of public service were often performing exceptional service that was too often accepted as routine. Realizing many public transit people, daily, go an "extra mile" to serve their passengers, this award has been presented for a wide range of achievements--including the saving of lives.

The award recipients (20 since April 1987), are nominated by their system managers and selected by the deputy director in charge of UPTRAN. Winners receive a beautiful framed certificate of recognition and a heart-shaped gold pin.

Award winners to date are:

#### Clare Knoblock -

Huron Transportation Authority - Clare, a dispatcher, saved a woman's life by following up when a senior rider missed her bus!

#### Elizabeth Smith -

Huron Transportatin Authority - Elizabeth, a bus driver, alerted officials when she spotted a mobile home fire, potentially saving lives!

#### **Thomas Lee Barber -**

Cadillac/Wexford Transit Authority - Thomas, a driver, rescued two small children from an automobile accident, possibly saving their lives!

#### Cherie Donnan -

Oscoda County Public Transit - Cherie, a driver, became revered as a helpful friend by her senior riders for continually going beyond the normal call of duty. Her commitment to service won her this award.

# Gar Floyd -

Oscoda County Public Transit - Gar, a driver, willingly and patiently assisted his senior riders, even escorting them into buildings and carrying packages for them. His devotion to his passengers and concern for their health and welfare earned him this award.

#### Thomas Russell -

Oscoda County Public Transit - Tom, a driver, regularly performed good samaritan deeds according to his riders. His outstanding record of friendly, helpful service earned Tom this award.

# Mary King -

Ludington Mass Transit Authority - Mary, a driver, routinely helped and looked after her riders. She cared. She would phone senior passengers who missed their scheduled rides; she took her grade school riders ChristmasCarolling!

## Harvey Whittle -

Shiawassee Council on Aging - Harvey, a driver, provided comfort and support for one of his senior riders by staying with her when she was ill until further help arrived. His riders know this is typical of his devotion and commitment.

#### Pete Gilmette -

Cheboygan County Council on Aging - Pete, a driver, has on record several good samaritan deeds. Once, he drove a distressed senior passenger to her daughter's home and waited with her until her daughter arrived! Pete's riders say he helps them with packages, opens doors, makes repairs, and delivers packages to shut-ins! All in the line of duty to Pete!

#### **Donna DeBow Smith -**

Eaton County Transportation Authority - Donna, a local volunteer and member of the system's Advisory Committee, exhibited a commendable spirit of service to her community and its public transit system. Her tireless efforts on their behalf won her this award.

#### **Bonnie Biddle -**

Hillsdale Dial-A-Ride - Bonnie, a dispatcher, was endeared by all who knew her and worked with her because of her concern for the riders of the Hillsdale system. For Bonnie, service to the customer is her top priority!

## Douglas Middleton -

Antrim County Transportation - Douglas, a driver, saved the life of a senior diabetic woman. Concerned when she did not call for her "usual" ride, Doug went to her home and found her unable to move. Because of his E.M.T. training, he recognized her diabetic symptoms and immediately called an ambulance. Beyond a doubt, he saved her life!

#### **Charles Ferrier -**

Yates Dial-A-Ride - Charles, a driver, spotted a forest fire in Yates Township, immediately notified his base station which alerted firefighters! His alertness prevented a potentially disastrous fire that could have endangered lives and property!

# Henry Tarnacki -

Cheboygan County Council on Aging - Henry, a driver, is a favorite of riders in the Cheboygan area. He delivers meals to shut-ins, helps with the local senior citizens olympics, and assists his riders whenever and however he can. His warm, good humor wins him friends everywhere and helped him win this award, too!

#### Tim Olson -

Dickinson/Iron County Community Action Agency - Tim, a driver, personifies "service". He's a frequent and willing volunteer to drive for special senior activities in the area. Tim donates his time and energy to assisting area seniors and handicappers, all of whom were happy to see him win this award.

#### Cecil St. John -

Menominee-Delta-Schoolcraft Community Action Agency - Cecil, a driver, was nominated for this award by letters from several area Human Scrvice Agencies. Everyone agreed he is a caring man who is very compassionate towards his riders. They told the story of a terrible snow storm that hit the area, and how Cecil waited until 1 a.m. to meet a bus carrying Foster Grandparents. Cecil knew when the bus arrived the seniors would need a way home. He worked nearly all night to be of service!

# Jernigan Jackson -

City of Detroit, D.O.T. - Jernigan Jackson, a 16-year veteran driver, spotted a fire in a Detroit apartment building. He raced to the building and alerted all the residents. Five people - three senior citiens, an infant and his mother - all escaped the fire unharmed, thanks to his quick, heroic action!

## Maggie Howard -

City of Detroit, D.O.T. - Maggie, a driver, was awarded this honor, posthumously. Maggie Howard gave her life in the line of duty as the result of a tragic traffic accident. The memory of her dedicated and loyal service to her system, her riders and fellow citizens earned her this award.

#### Lee Greenwood -

City of Detroit, D.O.T. - Lee, a 14-year veteran driver for the Detroit system, makes it a habit to watch over his riders. Lee has assisted his riders and fellow citizens with everything from boarding a bus, to saving their property, to protecting their life! He accepts it all as part of the job but we think he's a real winner!

#### Jane Perkins-

Capital Area Transportation Authority-Jane, a driver, while operating her bus, noticed that one of her passengers was in extreme pain. Due to Jane's quick action in taking the passenger to a local hospital, the heart attack victim's life was saved.

Our congratulations are extended to all these outstanding people. They exemplify the high caliber of dedicated individuals who work in Michigan's public transit industry.
