## REQUEST FOR SUPERLOAD INFORMATION

## PURSUANT TO PUBLIC ACT 561 OF 2002, (SEC.301) PERMIT APPLICATION AND/OR PERMIT FEES ARE NON-REFUNDABLE.

Requests for transport permit loads exceeding <u>16 feet in width</u>, <u>15 feet in height</u>, and/or <u>150 feet in length</u> are considered superloads.

The superload application process is initiated by submitting a superload application through the Michigan Permits and Routing System (MiTRIP) and completed by emailing the following information to <a href="MDOT-Superload-Review@Michigan.gov">MDOT-Superload-Review@Michigan.gov</a>.

**1. Shipper's letter** – Required to be submitted on company letterhead, at the time of application submission:

Reason why the load cannot be reduced in size Reason why the load cannot be shipped by rail or water

2. Route Survey Certification, Form 2465.

It may take <u>up to ten (10) business days</u>, from receipt of the MiTRIP application, shipper's letter, and Form 2465, before a permit is issued. If utility coordination is required (example: movement of a traffic signal) prior to movement, a MDOT prequalified contractor will be required to do the work. When a police escort is required by MDOT, the permit also requires that the vehicle, load, and driver be inspected by a motor carrier officer prior to movement.

Michigan State Police Operations Section coordinates the inspections and escorts and can be reached at (517) 241-8000.

State police escorts are typically conducted only on state trunk lines and expressways.

A separate permit is required for movement on county or local roads, issued by the respective jurisdiction.

Escort and inspection provisions may differ depending on local and county permit requirements.

## **ROUTE SURVEY CERTIFICATION**

INSTRUCTIONS: A certified route survey is required with a superload application exceeding 150 feet in length, 16 feet width, and/or 15 feet in height.
