- ➔ **Registration requirements:** Aircraft based in Michigan for more than 90 days, during a calendar year, must either be registered with the State of Michigan, or have a Claim of Exemption accepted by the Aeronautics Commission.
- ➔ **Annual registration period:** January 1 through December 31, of each year.
- ➔ **Annual registration fee:** One (1) cent per pound of the maximum gross weight or the maximum gross takeoff weight of the aircraft, whichever is greater. Gross takeoff weight cannot be changed without written certification from the manufacturer.
Note: Purchasers buying from a Michigan aircraft owner, obtain the current year's registration from the seller, complete the transfer information on the back of the registration, and send it to the address above along with the \$5.00 transfer fee.
- ➔ **Make check payable to:** State of Michigan. Please write the "N" number of your aircraft on your check.
- ➔ **Penalty:** There is a penalty of \$50.00 for failure to register or renew on time, with an additional \$5.00 penalty for each additional month, or fraction of a month thereafter.
