- ➔ **Registration requirements:** A current year Michigan aircraft dealer license is required to register aircraft as a dealer aircraft. Aircraft cannot be flown for general transportation purposes. It can be flown for sale demonstration purposes only.
- ➔ **Annual registration period:** January 1 through December 31, of each year. A dealer aircraft cannot be renewed until the dealer license has been renewed for the corresponding year.  
**Sale of dealer aircraft:** A dealer selling or exchanging aircraft subject to registration must send in the aircraft's completed transfer form and purchaser's civil aircraft registration fee (1 cent per lb. of maximum gross takeoff weight) at the time of the sale. Reference Act 327, Section 259.82.
- ➔ **Payments:** Dealer aircraft registration, purchaser aircraft registration, and/or airport directory purchase payments are made payable to the State of Michigan. (Registered dealer aircraft do not receive a complimentary directory.)
